2017 TIDEWATER MIXED CITY TOURNAMENT TOURNAMENT RULES

1. Entry closing date is October 2, 2017, unless schedule is filled sooner, or closing date is extended.
2. One-time participation in each event (Team, Doubles/Singles). If you enter doubles you must enter singles and vice-versa.
3. Individuals who are members of bowling organizations identified as "professional" are eligible for participation, however, not more than one professional bowler may compete on a four member team or two member team.
4. The Tournament will be open to USBC female and male members only. Tournament will consist of Handicap Mixed Team Event (2 USBC male members and 2 USBC female members); Handicap Mixed Doubles (1 USBC male member and 1 USBC female member); Handicap Singles and a separate Men's and Women's nine game Optional Handicap All Events Division; **Optional Scratch Singles Event Male and Female.**
5. Handicap is 100% of 220 scratch.
6. Prize ratio for team, doubles and singles will be at least one in six. Optional scratch singles event will be at least one in eight. Optional all events prize ratio is one in eight with **separate divisions for men and women.**
7. **Proper attire is required. (shirts, pants, skirts)(No Spandex or short/shorts).**
8. Prize fee will be returned 100%.
9. Entrants will use their highest USBC certified yearbook average based on a minimum of 21 games for the 2016-2017 season. If no 2016-2017 book average then a 2017 summer average of 21 or more games may be used. All others will bowl scratch. The 10 pin rule will not apply (Rule 319.a.2.)
10. Rule 319e will apply. (Average adjustment for entry in tournament.)
11. **Rule 319a-3. It shall be each entrant's responsibility to verify the accuracy of his/her average in handicap tournaments, whether originally submitted by the entrant, his/her team captain or others. Failure to use the proper average shall DISQUALIFY score if submitted average is lower than actual average thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average. In the case of teams of two or more entrants, the averages shall be combined to determine whether the correct total is higher or lower than the submitted total.**
12. Rule 319d.1.a. Entrants who have qualified for a cash and/or merchandise prize in the position standings prize list in any event in a tournament including all events, special features, special prizes and donated prizes within the previous 12-month period must report their actual score, position and amount won to the tournament management at time of bowling in a handicap or classified tournament for possible re-rating. Failure to comply with either of these provisions shall be cause to forfeit tournament entry fee and prize winnings. It is the entrant's responsibility to report his or her scores in any tournament where the prize payment has been already paid or has not been made but in which he or she has qualified for \$300 or more in a single event; \$500 or more in a single tournament or \$1000 or more in all tournaments within the last year.
13. **Entries submitted in the same envelope will not be scheduled on adjoining lanes unless a request to cross lanes is indicated on the form.**
14. Checks and money orders should be made to TMCT. Returned check charge of \$25.00 will apply.
