## 2018 LEAGUE OFFICERS INVITATIONAL SINGLES TOURNAMENT

1. **ELIGIBILITY:** Participation is limited to those members of the Tidewater Virginia USBC who are serving as a league officer (President, Vice President, Secretary, Treasurer, and Sergeant-at-Arms), Association Officers and Directors. Participation is limited to one squad.
2. **ENTRY CLOSING DATE:** Entries must be postmarked no later than midnight, January 3, 2018. Entries received bearing a later postmark will be returned. Entry fee must accompany completed application.
3. **TOURNAMENT AVERAGE:** Entrants must use their highest USBC certified league average as determined in the following sequence:
  - a. As published in the Association 2016-2017 yearbook.
  - b. A 2016-2017 average established in another Association, subject to verification by that Association's Manager.
  - c. The highest January 1, 2018 average for the current season based on a minimum of 21 games. (Verification must be brought to the tournament).
  - d. A 2017 summer league average of 21 games or more.
  - e. All others bowl scratch (220).
  - f. USBC Rule 319a (10 pin difference rule) DOES NOT APPLY.
  - g. Provision of USBC Rule 319e regarding average adjustment **WILL APPLY**.
  - h. Compliance with USBC Rule 319a-3 provides for disqualification if the average submitted is less than correct average. If average submitted is greater than correct average, the higher average will be used.
4. **HANDICAP:** Handicap is 90% of the difference between 220 and the bowler's average, based on the three game handicap chart.
5. **PRIOR WINNINGS:** All entrants must report tournament winnings of \$300 or more in a single event; \$500 or more in a single tournament or \$1000.00 or more in all tournaments with a 12 month period as set forth in USBC Rule 319d for possible average adjustment.
6. **ENTRY FEES:** The entry fee is \$25.00 per person as follows:

Expense Fund:	\$12.00
Prize Fund:	<u>\$13.00</u>
TOTAL:	\$25.00
7. **TIE SCORE:** A tie for championship is cause for a one-game roll-off at a time and date set by the Tournament Manager. The cost of any roll-off will be paid from tournament expense funds. For ties in all other positions, the monies for the positions involved will be combined and divided equally among the tied entrants. USBC Rule 326a.
8. **PRIZE MONEY:** Prize fees will be returned 100%. The ratio will be one place per seven entrants. Prizes will be awarded to both men and women divisions.
9. **OFFICIAL SCORE:** Computer screens will be the official score during each event. The recap sheet, when completed and signed will become the official record. Computer screens and recap sheets will be audited and obvious errors corrected.
10. **PROTEST AND APPEALS:** USBC Rule 329.
